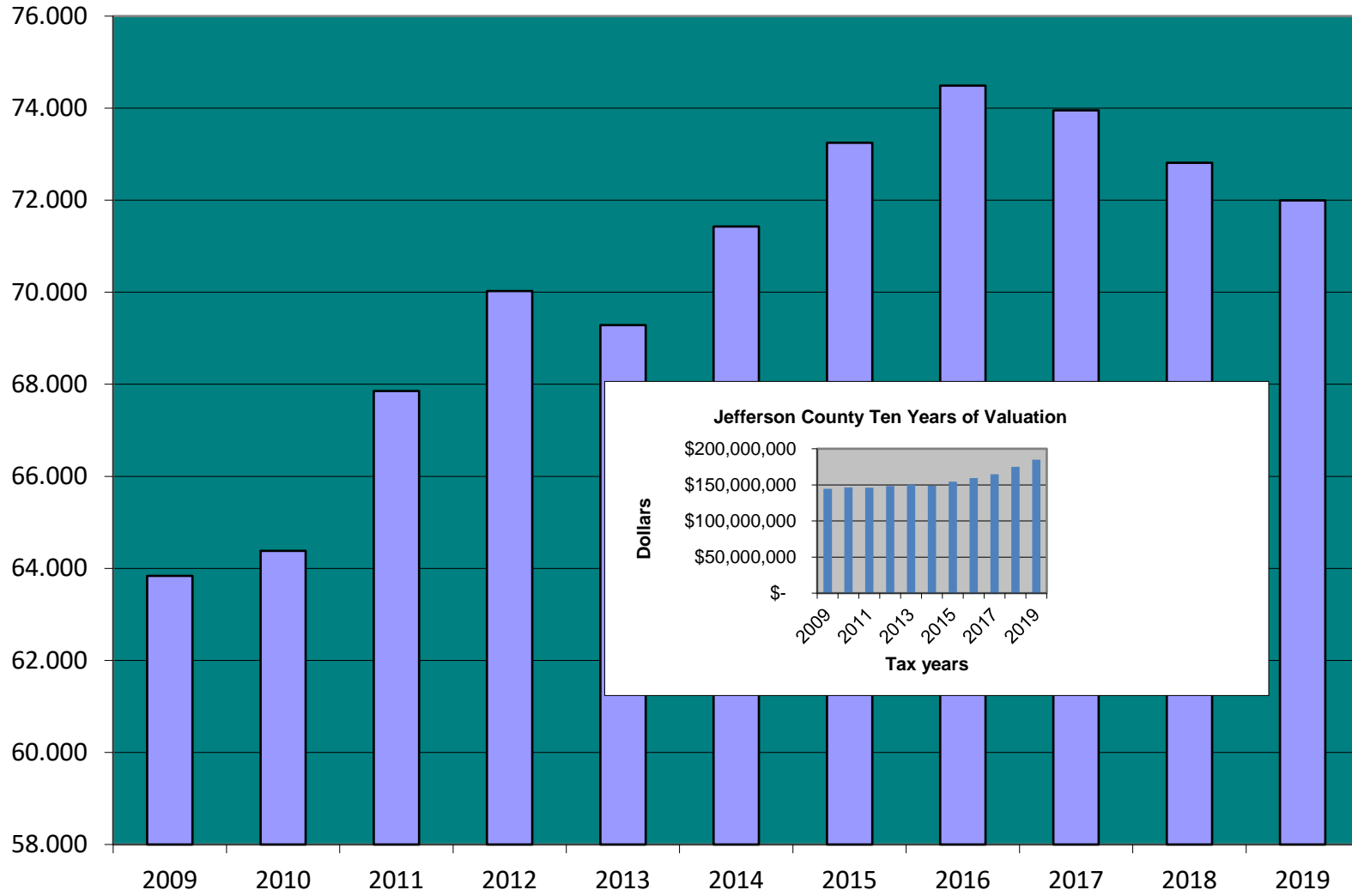

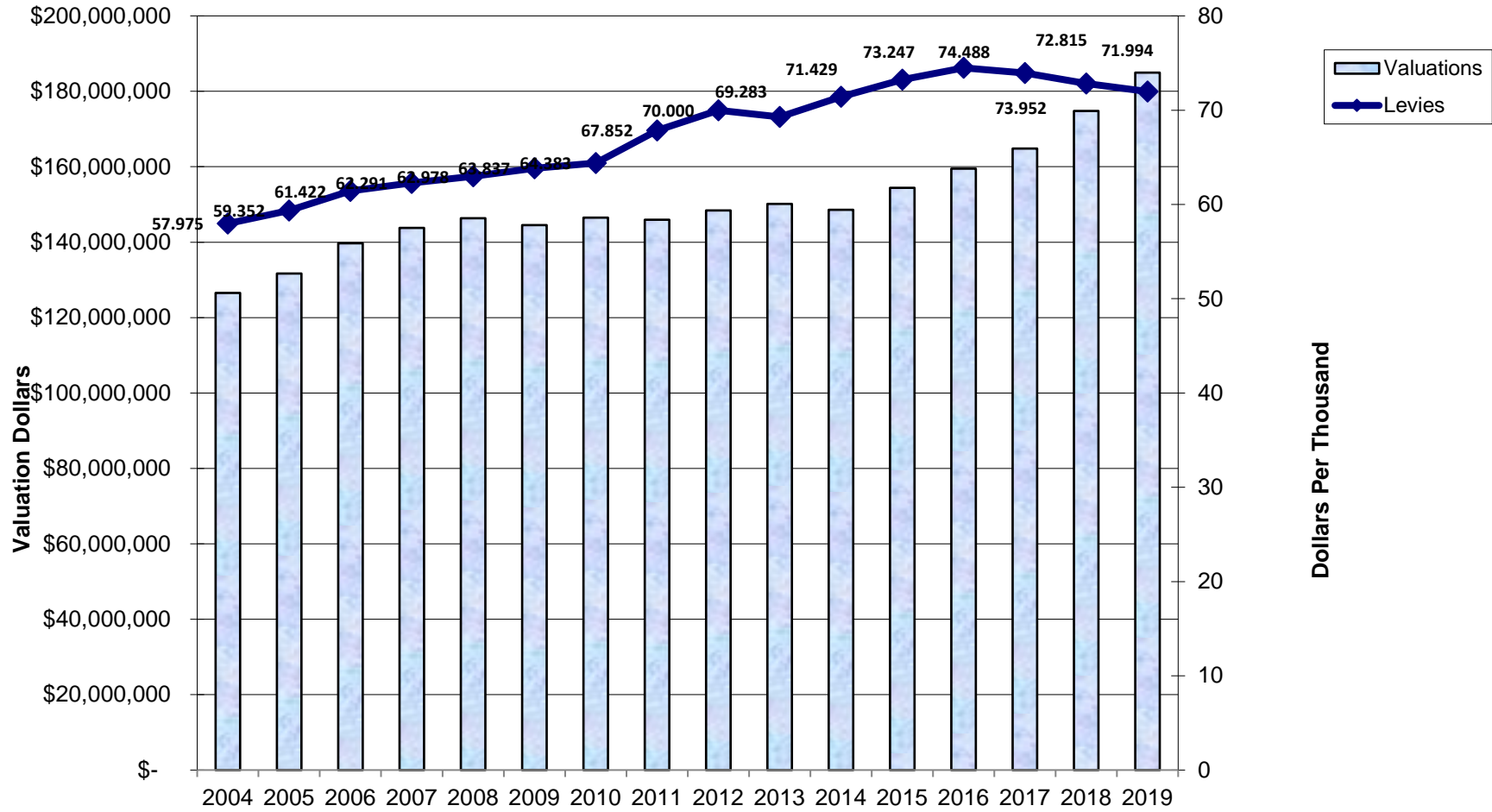

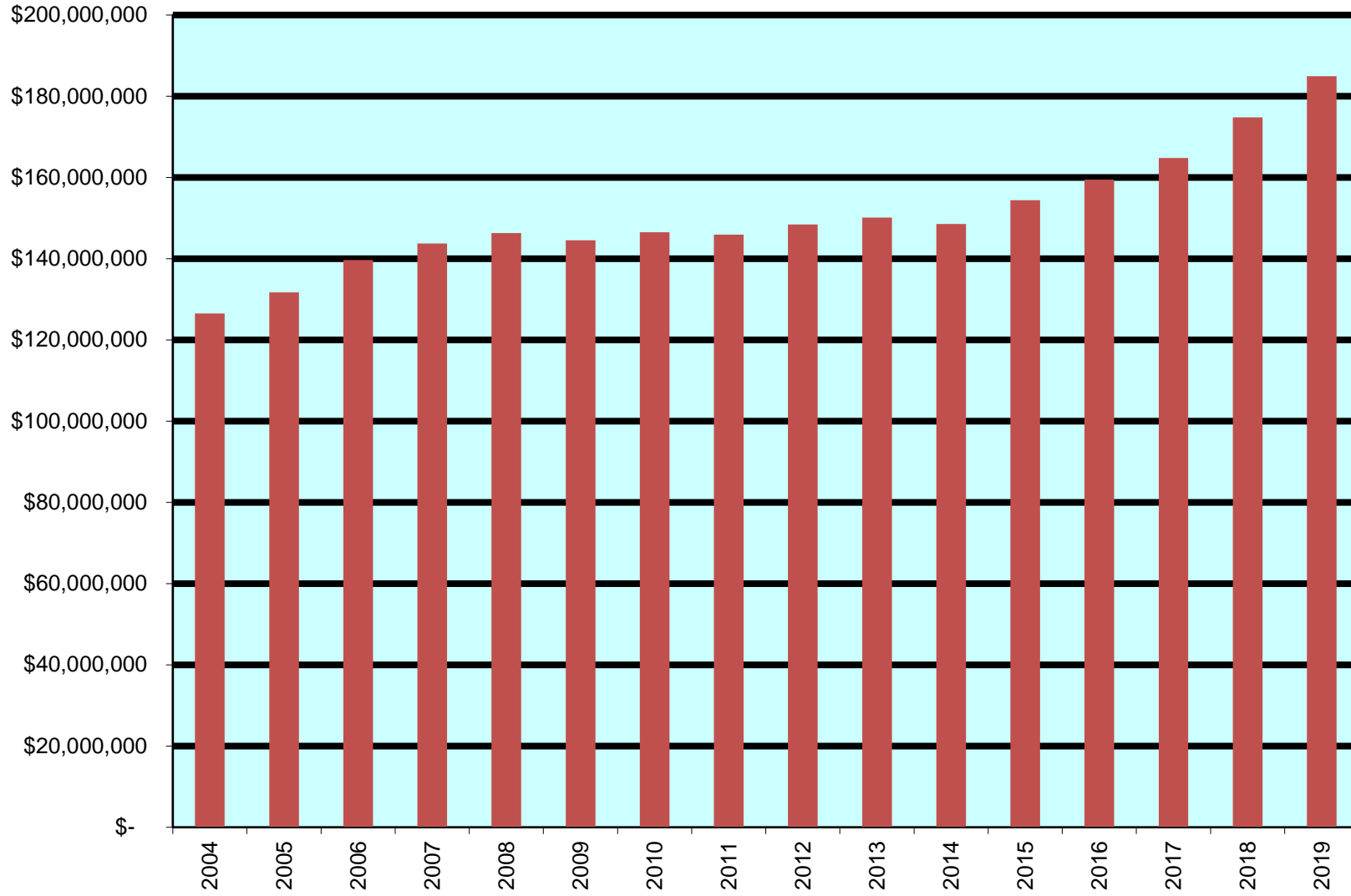

1992 School Finance Law	Uniform school general fund mill levy rate of 32 mills for 1992, 33 for 1993, 35 for 1994 and thereafter
